RETURNING Artists still need to be juried.

Participation last year does not guarantee a spot in this year's event.

Accepted Artist will Need to complete info form for event map with \$40 event Fee / \$40 refundable Deposit. Deposit will be returned at CLOSE of event when completed survey is turned in.

All work shown, must be made by the artist. Prints & Cards are acceptable. No purchased items for resale. No machine reproduction, commercially-made products or food items are allowed.

**All artists are required to be present and staff their booth for the entire event times.**

Acceptance Emails will be sent out in a timely manner.

#### Booth information:

There is no electrical service available in the park. Artists will be directed to parking after off loading. You will have ½ hour to off load. Please be respectful to other artists and move your vehicle as soon as possible. Also specify if you will need help setting up a tent or unloading heavy items.

Spaces will be approximately 10' x 10' – a WHITE canopy is recommended but not required. Weights are recommended as many spaces are not on grass.

As in the past, we may have a food vendor coming to your booth to take orders and deliver, however this is not guaranteed.

Information regarding this will be sent after vendors are finalized.
